



Initial Tilefish IFQ Allocation Interest Declaration Form

All persons and entities must declare their interest in Tilefish IFQ allocation. Individuals who have an interest in a Tilefish IFQ Allocation Permit are defined as and include, but are not limited to, individuals who own allocation, persons who are shareholders or officers in a corporation that owns allocation, persons who have formed a partnership (general or limited) that owns allocation, immediate family members (spouses, parents, children, and siblings) of those who own allocation, and any other entities that have an interest in a Tilefish IFQ Allocation Permit. If a corporation, partnership, or LLC is listed in Section A, shareholders, officers, and/or partners must be identified in Section B.
